

LAWSON PARK - ACCOMPANYING DOG POLICY

Please read this policy carefully. When you make a booking that includes an approved accompanying dog, you accept on behalf of your party the terms of this policy. It is your responsibility to ensure that all dog owners, guests and/or visitors accept the conditions of this policy while visiting the property Lawson Park, Hartley Vale.

"Dog" is a domesticated dog/pet. Breed, age and name of dog must be declared before approval will be given for he/she can stay with you at Long Alley Barn - Lawson Park. Only one approved dog is permitted to be at Lawson Park during the reservation period.

Long Alley Barn accommodation & surrounds is not fenced and a property dam is within 20 metres of the accommodation. Adjacent dwellings - main house and gardens are fenced and the property owners pet dog - a Kelpie x, if present at the time of your visit, will be kept secure within the home paddock and will only interact with your pet if both parties (& pets) agree.

In consideration for Lawson Park Management permitting a dog at Long Alley Barn, you hereby:

Agree to pay a fee of \$50 for my dog per stay. I understand that additional fees may apply in the event my pet causes damage.

Agree to pay Lawson Park Management any charges for any necessary cleaning or repair due to pet stains and/or damage, as determined within the sole discretion of Lawson Park Management. I hereby authorise my credit card on record to be charged for the cost of these additional services.

Agree the dog must be kept restrained on a leash or in a pet carrier when the pet is outside The Barn.

Agree the dog is not permitted to roam on the property unsupervised. The property has wildlife and the dog owner takes full responsibility for the actions of their dog during their stay. Dogs are not permitted to chase, attack or threaten other wildlife on our property.

Agree waste or any litter associated with my dog on the property, internally or externally is properly removed and disposed of and is not to be left on the property. Owner's must dispose of dog faeces in a sealed bag and placed in Council Bin at entry gate to Lawson Long Alley or as otherwise directed by Lawson Park Management at check in.

Agree my dog can not be left unsupervised within the Barn or on the property at any time. If you leave the property arrangements must be made to take the dog with you.

Agree, I must discuss and seek approval for a dog to be kept at the property in a closed cage IF it is intended to be left for a short time on the property unsupervised.

Agree, under no circumstances is a dog to sleep, sit or jump on any internal or external furniture during the guests stay on the property.

Agree, my dog is only permitted internally in the living area and restricted to concrete floor areas.

Agree to bring a suitable dog bed or floor covering for my dog to rest on. I understand I have to travel with all suitable dog food & water bowls for my dog. Under no circumstances are crockery or food containers from the Barn kitchen to be used to feed my dog.

Agree, I am responsible for the noise my pet creates and will ensure that my pet does not disrupt the quiet enjoyment of all using the property.

Agree, that should Lawson Park Management determine in its sole discretion that my pet is objectionable to the environment and other occupants of the property, I must immediately make other arrangements to house the pet outside the property.

I release Lawson Park Management, its owners, subsidiaries and affiliates from any and all liability for any injury and/or damage suffered by my dog while visiting Lawson Park.

Agree, that I assume full responsibility for any injury or damage caused or alleged to be caused to my dog and incurred or alleged to be incurred by any guest, employee or invitee of the Lawson Park property.

DEFINITIONS

"Booking" "reservation" or "period of hire" means the period for which you have paid to stay at the Property agreed to via your booking confirmation or by the written quote.

"Property" means Lawson Park, 154 Lawsons Long Alley, Hartley Vale NSW and designated event buildings, fixtures, fittings and equipment

"Long Alley Barn" 2 bedroom, 1 bathroom, 1 toilet accommodation. Open plan living and dining areas. Outdoor verandah, BBQ area. Wood Fireplace and wood burning slow combustion heating. Equipped kitchen w refrigerator, microwave, 2 burner gas cooktop, kettle and coffee machine, toaster and sandwich press.

"Management" means the owners and managers of the Lawson Park Property

"The owners" means legal property owner of 154 Lawsons Long Alley, Hartley Vale NSW 2790

"Guests" means the persons who stay overnight in the Property during the agreed booking

"Visitor" means a person permitted to visit a guest or the Property during the booking or event

"The Client" means primary Guest(s) who have engaged in booking the accommodation and/or venue hire for the purpose of the agreed event. If not the same as the Guest on the booking information, the client is subject to the responsibility of all Guests and Visitors to the Property.
